

Nicollet SWCD and the City of St. Peter have teamed up to apply for, and successfully receive, a 2021 Clean Water Grant, in the amount of \$374,625.00. The grant will allow Nicollet SWCD and the City of St. Peter to work directly with landowners in the Drinking Water Supply Management Area, to install practices that reduce groundwater pollution. Practices will include Cover Crop Incentives, Nutrient Management Incentives, Structural Practices (Terraces, Water Control Structures, Alternative Intakes), Nutrient Management Plans and Drainage Water Management Plans. Funds are available to landowners in the Wellhead Management Area. Interested landowners can call Blake Honetschlager or Eric Miller with the Nicollet SWCD for more information. (507) 232-2550.

## Fields to Fish Habitat

In April, the Seven Mile Creek Partners had the opportunity to interview DNR staff, while they stocked 300 adult brown trout in Seven Mile Creek County Park. Stocking took place the day before the trout fishing opener. Gustavus student, DeAnna Giles, worked with Nicollet SWCD and Great River Greening staff to turn the interview into a video, available to view at [7-milecreek.org](http://7-milecreek.org). This and other videos discuss opportunities for practices that can be implemented on the field, and in the stream, to improve fish habitat, water quality, and the farm's bottom line. One of the opportunities is seed distributors' prioritization of eastern Nicollet County, for new perennial and cash cover crops, Kernza® and winter camelina. Great River Greening is hosting a series of field days in the coming months, to talk with farmers about these new crops and introduce them to buyers in the area (including breweries and bakeries). ## CREP Overview

July 2<sup>nd</sup>, 2021 marked the end of the first and only CREP batching period in 2021. Nicollet County had four applications that were submitted for consideration. In total, there were 166.74 acres submitted for enrollment in 2021. Over 1,389 acres have been enrolled in the CREP program since 2017. Most of the interest has been from landowners and producers located within the flood plain of the Minnesota River. Nicollet SWCD has submitted 25 CREP applications since 2017, with all applications being funded. Twenty-one of the applications were for CP23, flood plain wetland restoration, while the other four were for CP23a, wetland restorations (non-flood plain). It is unknown at this time where the CREP program will go in the future, as the state was nearing the end of the allocated funds available for the program. Nicollet SWCD will continue to meet with and discuss potential projects with interested landowners and operators. Other programs available to landowners include; Wetland Banking and the USDA-NRCS Wetland Reserve Program. ## NWQI

In 2020, Nicollet Soil and Water Conservation District (Nicollet SWCD) applied for funding, and was selected for the planning phase of the National Water Quality Initiative (NWQI), for the Roger's Creek Watershed. Roger's Creek is located northwest of the city of St Peter, and the City of St Peter Drinking Water Supply Management Area. During the planning phase, Nicollet SWCD staff will complete a watershed assessment, and develop a six-part report analyzing and categorizing the characteristics of the watersheds, identifying the key issues and areas of concern. Once completed, the assessment report will be submitted to the United States Department of Agriculture - Natural Resources Conservation Service (USDA-NRCS). If selected for NWQI designation, landowners in the Roger's Creek Watershed, and the St. Peter Wellhead, will be able to apply for additional funding for conservation projects. Additional funding will be available through the Environmental Quality Incentives Program (EQIP) with NRCS. Contact Eric Miller for more information.
